BELLEVUE SKI SCHOOL RELEASE OF LIABILITY

1. The undersigned acknowledges that skiing and snowboarding are strenuous activities with certain inherent risks, some of which can be very serious ranging from minor strains and bruises to broken bones and catastrophic injury such as complete paralysis or even death to some participants. I freely and voluntarily accept full responsibility for all risks involved, including risks inherent in skiing and snowboarding in the ski area/mountain environment.
2. I accept my responsibility to ski and/or snowboard safely at all times, to abide by the Skier Responsibility Code, and to obey all posted behavior notices and any other ski area rules and policies. I also agree to read and abide by the rules and regulations of the Bellevue Ski School. A violation of these rules can result in the loss of skiing privileges and removal from the Ski School. Any equipment I use while skiing and/or snowboarding, I use at my own risk.
3. I agree that I will not sue or make a claim against Bellevue School District, Bellevue Ski Council, Bellevue Ski School, Ullr, Inc., Boyne USA, Inc. or any of its owners, officers, agents, or subsidiaries, including but not limited to, Ski Lifts, Inc., Crystal Mountain, Inc. and the U.S. Government-U.S. Forest Service, their respective agents, officers, directors, owners, contractors, volunteers, employees, insurers, and real and personal property owners, as well as equipment manufacturers and distributors, and all event sponsors (hereinafter "Released Parties") for any loss, injury, or damage resulting from any cause including negligence, which arises out of my participation in any activity at the ski area, including travel to and from the ski area, or participation in the Bellevue Ski School or Ullr Snow Sports Program, and also including but not limited to, use of the slopes, equipment, or any of the facilities or services on the premises.
4. I further agree to Release, Forever Discharge, Defend, Indemnify, and Hold Harmless the Released Parties of and from any and all loss, damage, liability, claims, liens, demands, actions and causes of action whatsoever arising out of or related to participation as described above, and also from any loss, cost, damage or injury, including death, of any person or damage to property of any kind resulting from any cause, including negligence, related in any way to the student's travel to and from the ski area, or participation in the Bellevue Ski School or Ullr Snow Sports Program's operations or the errors or omissions of the Program, its agents, subcontractors, volunteers, or any other person directly or indirectly employed by them, or any of them, while engaged in any activity associated with this Agreement, whether contractually or otherwise. This Release is also binding as to any other persons, including all family members, heirs, and executors.
5. If I am signing on behalf of a minor, I recognize that I may not release any claims the minor may have. However, I accept full responsibility for all medical expenses incurred as a result of the minor's participation as described above, including travel to and from Bellevue Ski School. I also agree to RELEASE, HOLD HARMLESS AND INDEMNIFY the Released Parties from any claims brought by or on behalf of the minor.
6. This Release does not apply to gross negligence or intentional acts.
7. I understand that the fee charged would be substantially higher if the Release were not part of the Participation Agreement.
8. I authorize the Released Parties to administer first aid as they deem necessary. I authorize transportation to a medical facility, at my sole expense, if deemed necessary by Released Parties. Further, in the case of serious illness or injury, if I cannot be reached, I give permission for treatment, including medical and/or surgical care necessary for the well-being of my child(ren), solely at my expense. I agree that upon transporting myself and/or the child(ren), to any medical facility, clinic or hospital that the responsibility of the Released Parties shall be totally fulfilled and the Released Parties shall have no further responsibility. I understand that Released Parties will, to the best of their abilities, attempt to notify me as soon as possible in the event of an emergency.

BELLEVUE SKI SCHOOL PARTICIPATION AGREEMENT

1. Classes and bus spaces are reserved for the entire season. There are no refunds or make up classes if a student misses a day.
2. If we must cancel an entire session due to weather, the season will automatically be extended one session. If the program cannot be completed by March 3, 2012 the Ski Council reserves the right to refund on a prorated basis or consider the session complete. All refunds are subject to a \$30 administration fee.

4. I grant permission to Ullr, Inc. and its agents or employees to use any images taken of me during the School day for use in any printed or electronic publications and hereby waive any right to royalties or other compensation arising from or related to the use of the images.
